2. Financial soundness certificate from Scheduled Bank showing annual turn over of the Firm.
3. Satisfactory balance sheet of the company for the last three years duly audited by the Chartered Accountants supported by Income Tax paid & detail of immoveable property owned by the firm or its Directors.
4. Income Tax Registration Certificate along with its latest renewal.
5. Details of Present Enlistment with Government / Semi Government and Autonomous Bodies including categories with copies of Registration.
6. Copy of registration with Pakistan Engineering Council or any other professional body.
7. CVs of Engineers / Technical Staffs to be posted on this work.
8. List of major jobs of similar nature executed during the last 5 years with Government / Private Agencies with performance certificate from the clients.
9. List of similar works in hand and their present status.
10. Under taking mentioning that the firm is not involved in any type of litigation at present. Also list of involvement of firm in any previous litigation.
11. An undertaking cum affidavit by the firm / contractor that:-
 - a. Neither the firm / contractor nor its Director / Stakeholders as a whole or as a part of any company / organization have been black listed by / defaulted with any Govt. Agency / Department / Organization.
 - b. The information supplied by the firm / contractor is correct.
 - c. The firm / contractor shall participate in tendering in case it is pre-qualified.
12. Tender Documents / Forms shall be issued to qualified Contractor(s) / Firms on payment of Rs.2,000/= (Two Thousand) in shape of pay order / demand draft (non-refundable) in favour of Pakistan Gems and Jewellery Development Company.
13. Any additional information along with proof.
14. Conditional tenders will not be entertained.
